APPLICATION PROCESS UPDATES

Current Job Openings / Postings on Jobspeaker

- All jobs have been closed as of 3/23/2020
- Positions can be reopened / reposted once shelter in place is removed

Future Job Postings

- Will be rejected during the shelter-in-place on Jobspeaker
- Can begin being posted as soon as the shelter in place is removed or a target date is announced by the state

Applicants

- We will be removing the ability to apply for eligibility beginning 3/23/2020
- This will be reopened once we have the ability to return to campus and / or we have a proper format in place for screening applicants through the entire process during Shelter in Place (including 19 verifications).

Incomplete Hires

- Students who were in the middle of being hired, will not be processed until we return from Shelter in Place
- If you are unsure, the only way to know for sure is to log into Jobspeaker and see the applicant's status as "hired".
- Incomplete packets, packets that were in progress, and packets that were not turned in will remain in limbo until the shelter in place is removed or a secondary format is introduced by the district to do so safely

Will my department's student employee(s) be paid through the end of the semester?

- District and Federal Work Study (FWS) Students
 - As of today, 3/24/2020, all district students will be paid for their work schedules through 4/7/2020.
 - Additional information beyond 4/7/2020 will be coming soon.

- CalWORKS Students
 - \circ $\;$ As of this email, the state had not made a complete announcement re: these students.

Can department student employee(s) work from home during the shelter in place?

- Answer is yes if:
 - Student employee has access to proper equipment, direct access via telephone, email, google docs, Microsoft Teams, zoom, SARS, etc.
 - Student employee(s) has work to do that is in scope of being a student employee
 - o Has a set schedule and hours included working during the shelter in place
 - The department has sufficient funds to do so.
- Answer is no if:
 - o Student does not have proper access as listed above
 - There is no work for this student to do at home for the department that is in scope of being a student employee
 - Had no schedule to work prior to the shelter in place
 - Department budget for student employees has been exhausted

How many hours a week can a department's student employee(s) work during the shelter in place?

- Same regulations apply as during a regular semester week:
 - 25 hours for all non-international students
 - 20 hours for all international students (this is not a "break" from classes, so summer and intersession rules will not apply here)

Work Experience On Campus Student Employees

• If your student employee is currently a Work Experience student, the faculty are working on plans to work with students to offer some various solutions to any work / hours that may be lost as a result of COVID-19.

- This may include completion of the course with less units than originally signed up for
- Revision of Learning Goals / Objectives based on new job duties can be accommodated
- Virtual meetings for the final meeting via zoom, skype, facetime, etc. will be permitted
