We acknowledge that we gather at Santa Rosa Junior College on the territorial traditional land of the Pomo People in Santa Rosa and the Coast Miwok People in Petaluma, past and present, and honor with gratitude the land itself and the people who have stewarded it throughout the generations. This land acknowledgement calls us to commit to continuing to learn how to be better stewards of the land we inhabit. We recognize that every member of the Santa Rosa Junior College community has benefitted, and continues to benefit, from the use and occupation of this land since the institution's founding in 1919. Consistent with our values of community and diversity, we have a responsibility to acknowledge and make visible the colleges' relationship to Native peoples. By offering this Land Acknowledgement, we affirm Indigenous sovereignty and will work to hold Santa Rosa Junior College more accountable to the needs of American Indian and Indigenous peoples.

Pursuant to Executive Order N-25-20: Suspends aspects of the Brown Act. Zack Miranda, Coordinator of Student Government Programs, presented on changes to the Brown Act:

- AB 2449 ends exceptions to allowing for remote access to meetings governed by the Brown Act
- Members can attend remotely for emergency reasons, no more than twice in a calendar year
- All remote attendees must have camera and audio on and disclose anyone else in the room who is 18+
- To be a permanent remote location, there are specific criteria. However, at this time we do not need to disclose those locations if we meet the following:
 - At least a quorum of the body’s members participates from a single physical location clearly identified on the agenda,
 - The location is open to the public and located within the body’s local jurisdiction,
 - A two-way A/V platform is provided, or two-way voice calling (with telephone access) and a live webcast,
 - Options are provided for public comment to occur via phone, internet service, or in-person,
 - If there is a disruption to the meeting broadcast, no action may be taken for the duration of the disruption,
 - Public comments may not be required to be submitted in advance
