V. Information Items (Reports and Discussion):

A. Officer Reports:

- Vice President of Clubs, PC: Discusses collaboration with SGA members on creating scholarships and getting the club card premium off the ground. Meetings are on Sundays at 7pm. No committee meetings this week but hosted office hours. Meeting tonight for BSU at 5pm.
- Vice President of Student Life, PC: Ally and I talked about club day. Tentative date was set for February 17th but only one club is activated on the Petaluma campus. Therefore we are encouraging clubs to activate their clubs so that this event can be held.
- Vice President of Marketing, PC: Ally is collaborating with Brandon on Club day. Clubs need to get activated so that they can participate. Ally is advocating for not only club activation but overall student involvement so that we can strengthen our student community on campus by having students get involved.
- Baha'i Club: Last Friday, the Baha'i Club presented the first of our Black History Month "Honoring Notable African American Baha'is" events, which featured the founder of the first black newspaper in the United States, the "Chicago Defender", which is still operating today. The Baha'i community of Sonoma County will be repeating this presentation tomorrow night. There will be no meeting this Friday, since it is an SRJC holiday. The Baha'i Club will host events the next 2 Fridays. The Baha'is of Santa Rosa sent a letter to the BSU and Baha'i Club thanking and congratulating both clubs on our joining Martin Luther King day event last month.
- Member at Large, Evelyn Navarro:
- Member at Large: Delashay Benson-Delashay further discusses the use of cameras during classes and how it is becoming an issue among students. She will be speaking at the department's meeting to further stress this issue. She will also be presenting at the Academic Senate and the Union. She further addresses how great it was that BSU and Baha'i club collaborated for the award presented last Monday. She also discusses the plan in the works for the Chamber of Commerce. Delashay discusses her want for Petaluma Council to work with her on the Ceaser Chavez event. Scholarship committee is up and running, scholarships need to be pushed towards Petaluma. She further addresses the struggle for clubs to get advisors which are preventing them from becoming activated clubs on campus. Clubs are decreasing in number on both campuses. AIDE will be hosting a lot of events. She mentions that Petaluma Council should work with the Police District on campus to raise money for new cadet uniforms. She attended Queer Corner's Valentine's Day event. Discusses how petaluma should host fun events to help get students involved. Reaching out to clubs is important to help get clubs involved. Board meeting today at 4pm. MAD meeting tomorrow night with Second Chance students.

Collaboration with these students should occur.

- Michelle Vidaurri: Small grant, Student Engagement Grant was made to the school specifically for students part of committees such as Guided Pathways. Students aren't as involved therefore this will help students receive more training time to get training on the student voice, in addition to governing training. Students will gain education on the SRJC tools through an equity perspective. Allows students to be fully prepared and active on school based committees. There will be compensation for committee participation. Finally, students cycling through will report back to new students on their experiences. SGA will be hearing about this. This grant needs to be active on the first day of February and needs to end after the spring term. Will make a difference in the lives of future students. Ken has a motion on the floor to extend the meeting by 30 minutes. If the presentation ends early then the meeting will adjourn early. The motion died at 3pm.
